**GENERAL RELEASE – READ CAREFULLY**  
**RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT**

In consideration of being permitted to enter upon the lands of the ranch, and further agree, (herein defined as being any path, trail, corral, stable, stall, paddock, field, pasture, arena, tack area, neighboring property, trail or grounds), for the purpose of riding, training, engaging in equestrian activities or otherwise, the undersigned for himself, his personal representatives, heirs, and next of kin, acknowledges, agrees and represents that he has or will immediately upon entering the property of the ranch and will continuously thereafter, inspect such lands and all portions thereof which he enters and with which he comes into contact, and does further warrant that his entry upon such lands constitutes an acknowledgement that he has inspected such lands and that he finds and accepts the same as being safe and reasonably suited for the purpose of his use, and he further agrees and warrants that if at any time he is in or about the ranch and he feels anything to be unsafe, he will immediately advise the ranch and releasees and will leave said grounds.

1. Hereby releases, waives, discharges and covenants not to sue the ranch or Equine Partners Inc., Teamwork Equine Services, Erin Murphy, Lisa Murphy, teachers, trainers, counselors and employees, or any agents of the ranch, all for the purposes herein referred to as “releasees” from all liability to the undersigned, his personal representatives, assigns, heirs, and next of kin for any and all loss of damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence of the releasees or otherwise while the undersigned is in or upon the lands of the ranch for any purpose.

2. Hereby agrees to indemnify and save and hold harmless the releasees and each of them for any loss, liability, damage or cost they may incur due to the presence of the undersigned in or upon the lands of the ranch or Erin Murphy whether caused by the negligence of the releasees or otherwise.

3. Hereby assumes full responsibility for risk of bodily injury, death, or property damage due to the negligence or releasees or otherwise while in or upon the lands of the ranch.

Each of the undersigned expressly acknowledges and agrees that equestrian activities are very dangerous and involves the risk of serious injury and /or death and/or property damage. Each of the undersigned further expressly agrees that the foregoing release, waiver and indemnity agreement is intended to be as broad and inclusive as possible under the laws of the State of California and that if any portion hereof is held invalid, it is agreed that the balance, notwithstanding, continue in full force and effect.

The undersigned has read and voluntarily signs the release and waiver of liability and indemnity agreement and further agrees that no oral representations, statement or inducements apart from the foregoing written agreement have been made.
